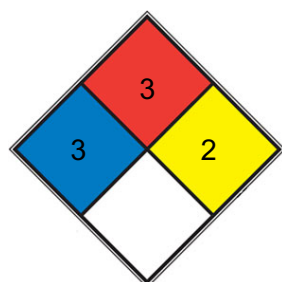

Body Protection
