## SECTION 4: First aid measures

### Description of first aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

SYMPTOMS: Symptoms of exposure to this compound include eye irritation. ACUTE/CHRONIC HAZARDS: This compound is an eye irritant. It may be absorbed through the skin. When heated to decomposition this compound emits acrid smoke and irritating fumes. (NTP, 1992)

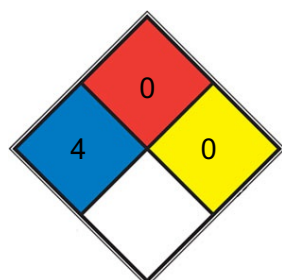

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures
