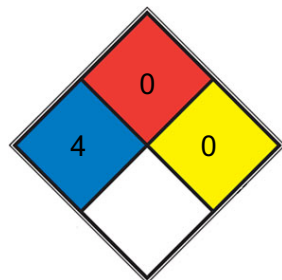

## SECTION 13: Disposal considerations

### Waste treatment methods

#### Product

Dissolve or mix the material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. Offer surplus and non-recyclable solutions to a licensed disposal company. Waste material must be disposed of in accordance with the Directive on waste 2008/98/EC as well as other national and local regulations. Leave chemicals in original containers. No mixing with other waste. Handle uncleaned containers like the product itself.

#### Incompatibilities

The aqueous solution is a medium strong base. Reacts with water, strong acids; hot surfaces; causing decomposition and a toxic hazard.

#### Waste Disposal

Liquid or solid: make a strongly acidic solution using hydrochloric acid. Slowly add sodium sulfite to the cold solution. Stir mixture producing sulfur dioxide. Heat, forming dark-gray selenium and black tellurium. Let stand overnight. Filter and dry. Ship to supplier.
