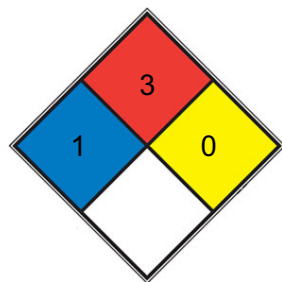

Other Information
