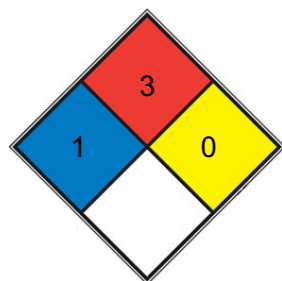
Advice for firefighters

Incompatibilities
