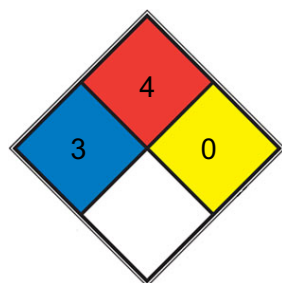

##### **Body Protection**
