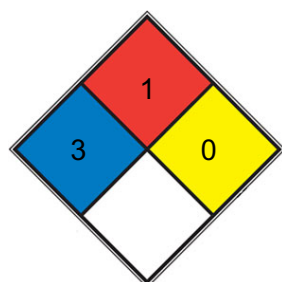

## Product
