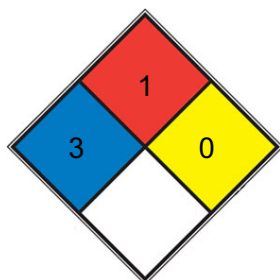

##### Eye/face protection

##### Skin protection
