## SECTION 4: First aid measures

### Eye Contact

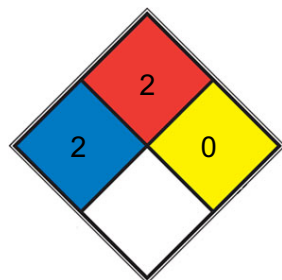
