If inhaled

Emergency and supportive measures: Maintain an open airway and assist ventilation if necessary. Treat coma, hypotension, arrhythmias, and anaphylaxis if they occur. Extracorporeal circulatory assistance (eg, balloon pump or partial cardiopulmonary bypass) has been used for short-term support for patients with acute massive overdose with 20% lidocaine solution and inadvertent intravascular administration of bupivacaine. 
