#### General advice

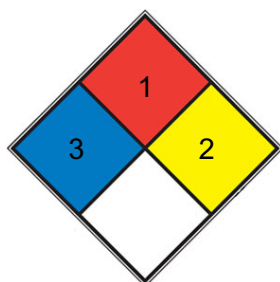
