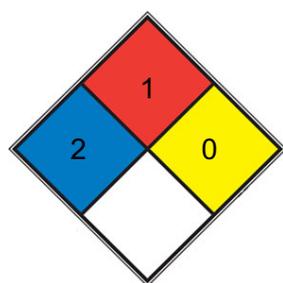

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
