# Description of first aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature.

### Persistence and degradability

AEROBIC: Acesulfame is not eliminated in wastewater treatment plants located in the Canton of Zurich, Switzerland and was shown to be very persistent in surface waters. Incubation using activated sludge resulted in no degradation within 7 hours at 15 deg C(1).

#### Bioaccumulative potential

An estimated BCF of three was calculated in fish for acesulfame(SRC), using an estimated log Kow of -1.33(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

#### Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of acesulfame can be estimated to be 4(SRC). According to a classification scheme(2), this estimated Koc value suggests that acesulfame is expected to have very high mobility in soil. The estimated pKa is 5.67(3), indicating that this compound will exist partially in the anion form and anions do not absorb more readily to soils containing organic carbon and clay than their neutral counterparts(4).

# Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
