#### General advice

Carbon oxides

Vapors are heavier than air and may spread along floors. Forms explosive mixtures with air at elevated temperatures.

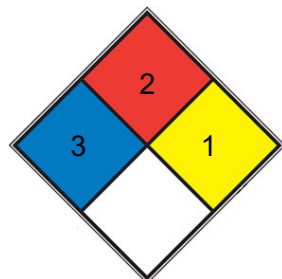
### Advice for firefighters

## SECTION 6: Accidental release measures
