SECTION 4: First aid measures

Description of first aid measures

General advice

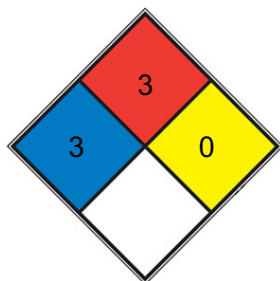
Advice for firefighters
