Waste treatment methods

Product

Ammonium oxalate is a reducing agent and also reacts as a base to neutralize acids and reacts with oxidizers generating carbon dioxide. Incompatible with oxidizers. Keep away from alkaline materials, strong bases, strong acids, oxoacids, epoxides.
