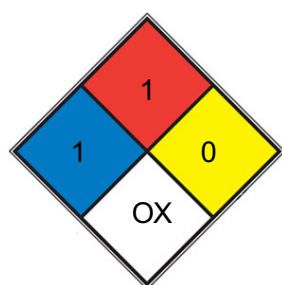

### Waste treatment methods

#### Product

Offer surplus and non-recyclable solutions to a licensed disposal company.
