Neonatal deaths from respiratory distress secondary to goiter have been reported. Iodides have been known to cause drug-induced fevers, which are usually of short duration., Ingestion may provoke the following symptoms:, hypertension, gastroenteritis, contractions of the cardiac muscles, muscular paralysis, slow irregular pulse, Vomiting, burning sensation, Cough, wheezing, laryngitis
