ACGIH recommends environment containing benzo(k)fluoranthene should be evaluated in terms of the TLV-TWA for coal tar pitch volatile, as benzene soluble 0.2 mg/m³. Insufficient data are available on the effect of this substance on human health, therefore utmost care must be taken.
