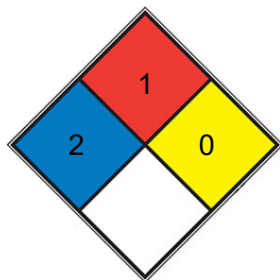

#### Skin protection
