## SECTION 4: First aid measures

### **Description of first aid measures**

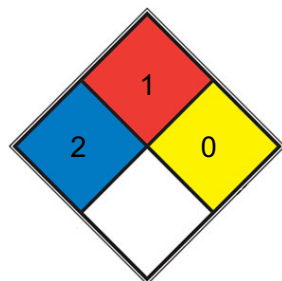
