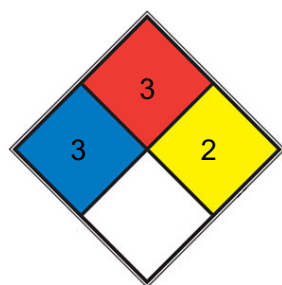

Body Protection
