Eye contact

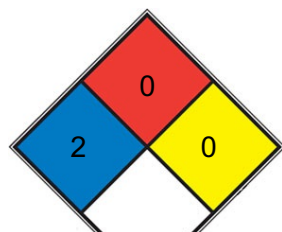
