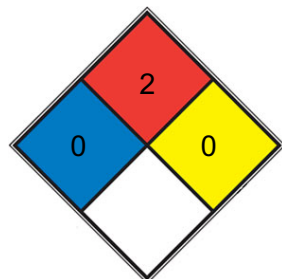

Eye/face protection

Skin protection
