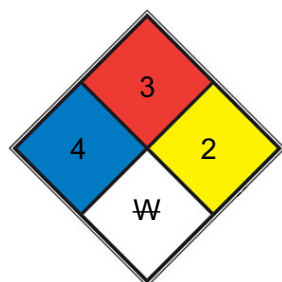
### Specific Hazards Arising from the Chemical

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Evacuate danger area! Consult an expert! Personal protection: complete protective clothing including self-contained breathing apparatus. Do NOT wash away into sewer. NEVER direct water jet on liquid. Collect leaking and spilled liquid in sealable dry non-plastic containers as far as possible. Absorb remaining liquid in sand or inert absorbent. Reacts violently with oxidants. Reacts violently with water. This produces hydrogen chloride (see ICSC 0163). #### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill.
