## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### **Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Rinse with pure water for at least 15 minutes. Consult a doctor.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

### Indication of any immediate medical attention and special treatment needed

VETERINARY: Injured capillaries cannot be mended, but other measures may save the animal. Restraint & handling should be minimized. A sedative or tranquilizer may be of assistance in restraint, calming ... & reducing locomotion, thus decreasing tissue oxygen demand. Oxygen may be given, but manual pumping of chest is not advisable. Dyspnea may be relieved by thoracentesis. Clotting factors should be provided in form of blood transfusion (20 ml/kg, 1/2 injected quickly). Warfarin should be antagonized with slow iv injection of vitamin K1. Dogs & cats are given 5 mg/kg. This dose is repeated for 2 more days, using im route. Larger animals are given 0.5 to 1 mg/kg, & oral vitamin K1 should be administered daily for 4-6 days. The vitamin will not evoke a sudden dramatic cure; but bleeding tendency will gradually abate as clotting factors begin to be synthesized ... Menadione (vitamin K3) is not as effective as vitamin K1 ... Residual defects such as lameness or CNS signs from localized hemorrhages may disappear with gradual resorption of extravasated blood. Liver damage may be compensated by regeneration of hepatic cells. Warfarin

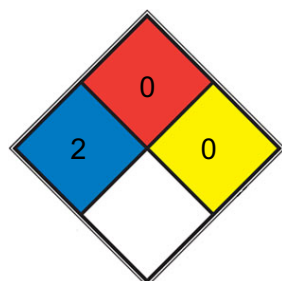

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

### Precautions for safe handling

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

### Conditions for safe storage, including any incompatibilities

Dicumarol should be stored in well-closed containers at a temperature below 40 degrees C (104 deg F), preferably 15 to 30 deg C (59 to 86 deg F), and kept away from direct sunlight. The manufacturer recommends storage below 25 deg C (77 deg F).

### Toxicity

Toxicity to fish: LC50 Pimephales promelas (fathead minnow) 5.11 mg/l/96 hr (95% confidence limit 4.18 - 6.24 mg/l), flow-through bioassay with measured concentrations, 24.5 deg C, dissolved oxygen 7.2 mg/l, hardness 44.3 mg/l calcium carbonate, alkalinity 44.0 mg/l calcium carbonate, and pH 7.8.

### Bioaccumulative potential

An estimated BCF of 8 was calculated for dicumarol(SRC), using a log Kow of 2.07(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC), provided the compound is not altered physically or chemically after released into the environment(SRP).

### Mobility in soil

The Koc of dicumarol is estimated as 320(SRC), using a log Kow of 2.07(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that dicumarol is expected to have moderate mobility in soil.

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
