Description of first aid measures

If inhaled

Other symptoms include irritation, nausea, vomiting, mild and transitory auditory hallucinations, mild and transitory visual hallucinations, cephalalgia and dizziness. ACUTE/CHRONIC HAZARDS: This compound is an eye irritant. When heated to decomposition it emits very toxic fumes of chlorine and nitrogen oxides. (NTP, 1992)
