Eye contact

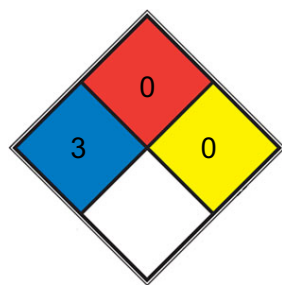
