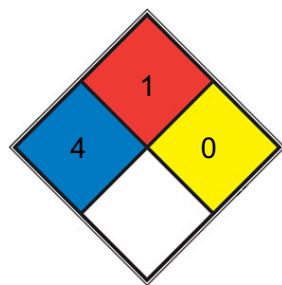

practices. Wash and dry hands.

#### Body Protection
