#### General advice

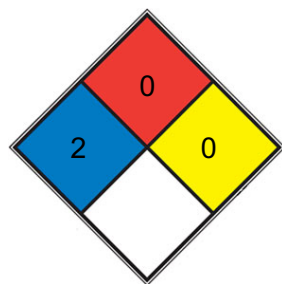
