4.1 Description of first aid measures

Eye contact

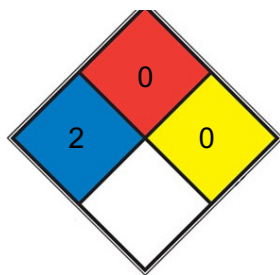
