General advice

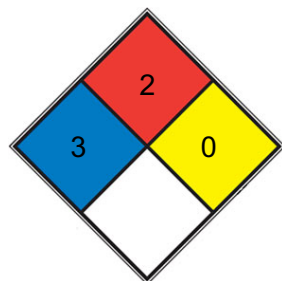
Advice for firefighters
