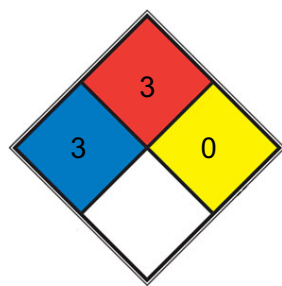

##### Body Protection
