

Symptoms of exposure include: skin rash, running nose, headache and irritation of the mucous membrane. For severe cases the skin may show pimples, boils, hives, blisters and black and blue spots. lodides are readily diffused across the placenta.

Neonatal deaths from respiratory distress secondary to goiter have been reported. lodides have been known to cause drug-induced fevers, which are usually of short duration.
