Eye contact

Inhalation

Wash out mouth with water; Do NOT induce vomiting; call a physician.

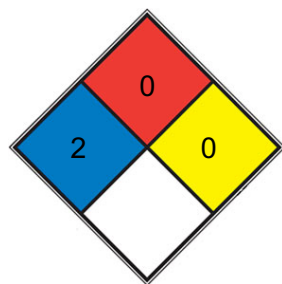
