### 4.1 Description of first aid measures

#### Eye contact

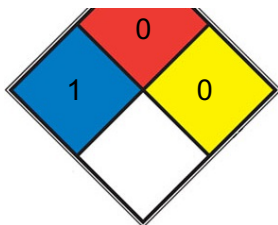
