**4.1 Description of first aid measures****Eye contact**

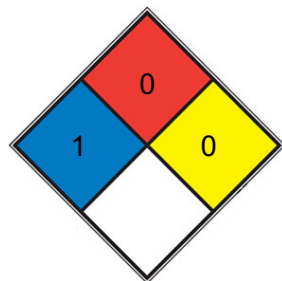
