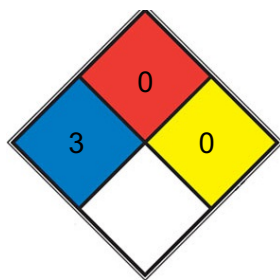

Skin protection
