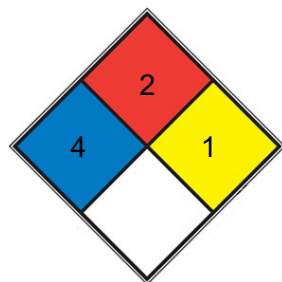
## Advice for firefighters

## Further information
