Eye Contact

Most important symptoms and effects

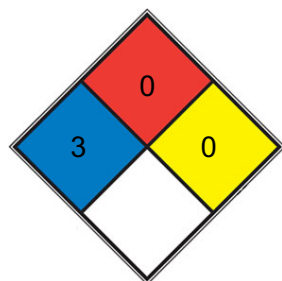
