If inhaled

Persistence and degradability

PURE CULTURE: Vitamin E was biodegraded by aerobic bacterial communities (genera Idiomarina and Bacillus), isolated from marine sediment and microbial mat sample(1); biodegradation appeared to involve an initial omega-oxidation of the isoprenoid side chain and subsequent beta-oxidation, affording 2,5,7,8-tetramethyl-2(2'-carboxyethyl)-6-hydroxychroman(1).

Bioaccumulative potential

An estimated BCF of 39 was calculated in fish for vitamin E(SRC), using an estimated log Kow of 12.2(1) and a regression-derived equation(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is moderate(SRC), provided the compound is not metabolized by the organism(SRC).

Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of vitamin E can be estimated to be 2.5X10+7(SRC). According to a classification scheme(2), this estimated Koc value suggests that vitamin E is expected to be immobile in soil.
