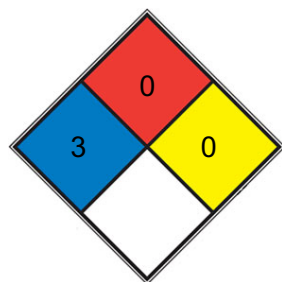

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

Warfarin suppresses the formation in the liver of prothrombin and factors VII, IX and X resulting in reduced blood clotting capabilities, increased capillary fragility and significant risk of hemorrhage. Warfarin is a cumulative poison, although acute poisonings have occurred from significantly large single doses. Manifestations of poisoning may be delayed for a few days to weeks. Signs of poisoning include nose bleeds, bleeding gums, pallor, hematomas around joints and buttocks, and blood in the urine and feces. Other symptoms include back pain, bleeding

lips, mucous membrane hemorrhage, abdominal pain, gastrointestinal bleeding, vomiting, and petechial rash. Dermatological effects have included skin necrosis and alopecia. Later effects of warfarin poisoning may include paralysis due to cerebral hemorrhage and finally hemorrhagic shock and death. There are no immediate warning signs of warfarin overexposure. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated. (Warfarin sodium)
